Biographical Sketch

Richard O. Reisem (b. April 15, 1930) was born in Oregon. He attended Iowa State University, completing major studies in architecture, history, and journalism and serving as editor of the university newspaper. Following his graduation in 1955, Reisem joined Eastman Kodak's Communications and Public Affairs department and relocated to Rochester, NY. He worked for the company for the duration of his 31-year career, including as a speechwriter and as special marketing promotion producer. Reisem developed a strong interest in local history and architecture. He was a member of the Rochester Preservation Board and, in 1980, helped found the Friends of Mount Hope Cemetery. Additionally, Reisem served as a trustee of the Landmark Society of Western New York for more than two decades. Following his retirement in 1986, Reisem authored 16 books on local (i.e., Rochester and western New York) history, including six about Mount Hope Cemetery. An avid avocational organist, he was also a member of the Rochester Theater Organ Society. In 2012, the Landmark Society of Western New York awarded Reisem with a Special Achievement Award for his contributions to upstate New York as a researcher, author, and preservation activist.

Reisem initiated the S.T.O.P. (Save the organ, please!) project after hearing that the Eastman Theatre renovations of 1971 would place the future of the theatre's organ in jeopardy. He organized a mailing list, appeared in the local newspapers and wrote letters to the school administration, including a detailed report to Richard Sproull, President of the University of Rochester.

Although his project failed and the organ was removed, his documentation of the organ during this incident provides insight into its history.

These papers were received as a gift from Richard Reisem on September 18, 2009.

Restrictions and Use

There are no restrictions on research use of the Richard Reisem Papers.

Associations

The Special Collections department houses several other collections and scrapbooks related to local music history. In addition to several individual and organizational collections that are of particular local interest, the department maintains a local history file that contains assorted materials relating to Rochester-area music, including people, organizations, and institutions. Additionally, the department houses approximately 200 scrapbooks containing press clippings pertaining to musical life in Rochester, with a particular focus on musical events and news with connections to the Eastman School of Music; the clippings, which are primarily from Rochester-area newspapers, date from 1921–1979.

DESCRIPTION OF SERIES

The Richard O. Reisem Papers have been divided into two series, which are further divided into the sub-series outlined below.

Series 1: Eastman Theatre Organ

This series includes correspondence, newspaper articles and pamphlets compiled by Richard Reisem regarding the S.T.O.P. (Save the organ, please) project, which was created in an effort to preserve the Eastman Theatre organ. They are separated by subject into the sub-series noted below.

Sub-series A: Photographs

This sub-series includes 96 color photographs in an album as well as negatives and color slides of the Eastman Theatre Pipe Organ.

Sub-series B: Organ specifications


This sub-series includes two copies of a pamphlet issued by the Austin Organ Company regarding the specifications of the Eastman Theatre Organ.

Sub-series C: S.T.O.P. documents

This sub-series consists of all documents related to Richard Reisem's S.T.O.P. (Save the organ, please!) project, including individual letters and postcards in support of S.T.O.P. It also contains a three-ring binder compiled by Richard Reisem which includes correspondence with administration at the University of Rochester and other supporters of S.T.O.P., newspaper clippings, quotes about the organ and other supporting materials.

Series 2: Skinner organ – George Eastman House

This series is comprised of one document of correspondence regarding the preservation of the Skinner organ in the George Eastman House.
